## US Conference of Mayors Adopts Resolution Urging Congress for Continued Arts and Culture Relief Funding

On Monday, June 6, 2022, the United States Conference of Mayors (USCM) adopted a resolution urging Congress to provide continued arts and culture relief funding in the wake of the COVID 19 pandemic. Mayors from cities across the nation, in collaboration with the San Francisco Arts Alliance, reinforced federal policy recommendations advanced by more than 60 national, regional, and state arts organizations and called on Congress to address the urgent needs of the nation's arts and culture sector and to take prompt and coordinated action to integrate arts, culture, and the creative economy into our national recovery and revitalization efforts. This action would ensure urgent relief for artists, who are drivers of wellbeing in their communities and essential arts and culture organizational partners.

Examples of action the mayors urged federal action are on reinstating the Employee Retention Tax Credit for Q4 of 2021, expanding the time to use SVOG to include costs through March 11, 2023, and reinstating the above-the-line, universal charitable tax deduction.
